Call to Order:

Temporary Chairman: Dan Fetterman made a motion to appoint Calvin Fox as temporary Chairman. John Long seconded. Motion approved.

Wage Increase: There was discussion on the amount of raise to give the regular hourly employees especially Trevor Webb, as he is a new part-time employee. John Long made a motion to give a 3% cost of living raise to all of the hourly employees.

Minutes: The minutes of the January 6, 2020 meeting was presented and approved.

Recognition of Guests: Pat Brewster asked if the Board would mind if she did some research on a "Dumpster Day" for the Township. The Board agreed to allow her to do this. Aaron Bartholomew questioned why all of the cones were in the front of the building. The Board explained food bank volunteers are here several days throughout the month and food bank is now two days a month and the road crew is trying to protect the grass. When the parking lot is paved, the Township will come up with a different solution.

Zoning and SEO Report: N/A

Mt. Pleasant Sewer: John Bauer reported the plant is running okay. The new flow meter has been installed and is running fine.

Woods Edge Sewer: John Bauer reported the plant is running okay.

Roadmaster: Calvin Fox reported the road crew has been doing tree removal, equipment repair and equipment, winter maintenance, and the cinder shed is full.

Old Business:

TRUCK LOAN RATES: After discussion on how to pay for the truck and the loan rates and payments, John Long made a motion to pay for the spreader/plow package from Bradco in the amount of 38775.56 out

of Liquid Fuels. Dan Fetterman seconded. Motion approved. John Long made a motion to take a loan with a 5 year term and 3.19% interest rate, with First Columbia Bank, for the remaining amount of the truck purchase. Dan Fetterman seconded motion approved.

2018 Audit: Erika Burkhart explained the audit came back with no findings with the exception of the recommendation for segregation of duties.

New Business:

RESOLUTION TO APPOINT CPA: Erika Burkhart assured the Board the legal advertisement was placed in the local newspaper to appoint a CPA. John Long made a motion to pass the resolution for the township to appoint a CPA to perform the 2019 audit. Dan Fetterman seconded. Motion approved.

APPPOINT CPA: John Long made a motion to appoint Herring, Roll, and Solomon as the CPA to perform the 2019 audit for \$5800 and a 10% discount if the audit is not complete before 12/31/2020. Dan Fetterman seconded. Motion approved.

For the Good of the Township: Calvin Fox explained he would like to meet with Steve Kehoe to start writing the bid to pave the driveway.

Adjournment: With no further business left to discuss, Supervisor Dan Fetterman made a motion to adjourn the meeting, Supervisor John Long seconded, motion approved. The meeting was adjourned at 8:00 pm.
