**Recognition of Guests:** Don Bogert: What is expected for winter maintenance for Stoneybrook. Doesn't feel it is plowed wide enough. Don Bogert: There was money available for stream banks in 2018. Lori Wurster: presented petition to have speed limit changed on Savage Hill(attached). Cal Fox response: Asked Chief Patel to run a speed trap to try to slow people down and possibly borrow the speed limit machine to be placed on the road. Chief Patel agreed.
