Minutes: The minutes of the June 2, 2022 meeting was presented and approved.

Recognition of Guests: Don Bogert wondered when the work in Stoneybrook Creek would begin. Calvin Fox expected within the next 2 weeks.

Police Report:

Zoning and SEO Report: Chris Bower will be performed the 537 plan inspections on all of the properties rather than the required half. There were no malfunctions.

Mt. Pleasant Sewer: Everything running ok

Woods Edge Sewer: Everything running ok

Roadmaster: Calvin Fox reported they worked on the electrical for the police dept, they have been mowing, cold patching roads in preparation for seal coat, and completed Belles Road. The State will crack seal and dura patch roads as part of agility.

Old Business:

SOLAR ORDINANCE: John Long made a motion to accept the **draft** Ordinance as presented at the hearing with the addition of the revision of the definition of Planning Commission; "Section 1 PLANNING COMMISSION: The Planning

Commission of Orange Township if existing or otherwise the Columbia County Planning Commission.” Dan Fetterman seconded. Motion approved.

SOLAR ORDINANCE LEGAL NOTICE: John Long made a motion to advertise the solar ordinance as presented to be considered for adoption at the August 4, 2022 regular meeting. Dan Fetterman seconded. Motion approved.

MOUNT PLEASANT SEWER: Executive Session held 6/23 to discuss the offer of \$10,000 to Zeisloft Estate for the purchase of the sewer plant property.

New Business:

STATE AUDITOR GENERAL REIMBURSEMENT: John Long made a motion to approve a refund in the amount of \$1156 to State Auditor General for the overpayment they sent in 2019 for Municipal Pension. Dan Fetterman seconded. Motion approved.

MILEAGE REIMBURSEMENT: John Long made a motion to approve the state Rate for mileage which was increased from \$0.585 to \$0.62.5, due to rising fuel costs, July 1 until December 31, 2022. Dan Fetterman seconded. Motion approved.

SHREDDING OF DOCUMENTS: John Long made a motion to accept the resolution to dispose of documents notated in resolution provided for 2012 and all prior years as per state record retention law. Dan Fetterman seconded. Motion approved. Resolution # 07072022

For the Good of the Township: COG inspector was hired. Police contract terms were offered to the Borough, waiting for their response.

Adjournment: With no further business left to discuss, Supervisor John Long made a motion to adjourn the meeting, Supervisor Dan Fetterman seconded, motion approved. The meeting was adjourned at 7:47p.m.
