Old Business:

Remodeling of garage bay for police department bid opening: Upon review of the bids, the Supervisors were not satisfied with the breakdown of services SR Custom Homes provided. In addition to this, SR Custom Homes planned to use knock-down door frames on exterior doors and this was not satisfactory to the Supervisors. The Supervisors did not feel the bid from SR Custom Homes was complete enough to award it to them. The Township plans to perform the

following tasks: electrical, painting, flooring, and countertop. Once these items are pulled out of the bids, SR Custom Homes price is more than Marr Development. Supervisor John Long made a motion to award the bid to Marr Development. Dan Fetterman seconded. Motion approved.

COG Bid: John Long made a motion to accept Russell Standard bid in the amount of 124304.66. Dan Fetterman seconded. Motion approved.

New Business:
