Woods Edge Sewer: Jeff Bauer reported everything is running ok. Received new sand and had work to do before it could be placed in the filter.

Roadmaster: Calvin Fox reported; seal coating is completed, agility work will be done next week to replace pipes on Gass, Dietterick and grading Buck, Megargell, Savage Hollow and Martenas, tractor repair, mowing. The Oman road grant was approved and the road will be started in the spring.
