Recognition of Guests: Don Bogert expressed his extreme concern regarding tannerite explosions from his neighbor's property. Don Bogert stated the explosions rattled his home and knocked glass from a shelf. David Bogert stated the explosions scared his children into the basement. After Chief Patel explained tannerite was a legal item and that he had spoken to District Judge Brewer regarding this issue, there was nothing he could enforce. Don Bogert wants the Township to enforce the nuisance ordinance. It was agreed upon that Chris Bower would be contacted to write a letter in accordance with the nuisance ordinance. David Bogert requested a school bus sign be placed near his home for the safety of his children. PENN DOT will be contacted to perform a bus sign study. After the results of the study are received and the sign placement is determined and approved, the Township will provide David Bogert with a sign quote as he will be responsible for the cost of the sign, and costs associated. David Bogert is also concerned about speeding on Stoneybrook Road. Chief Patel is in the process of borrowing automated speed signs which will be placed on Stoneybrook Road to track speed for several days. Rick Megargell was also very concerned about the tannerite explosions and has researched and found ordinances in Pennsylvania that have been passed with regard to tannerite and will send the information he found to the Township.
