**Call to Order:**

**Old Business:**

487 flow meter: John Long made a motion to approve the quote from Moyer Instruments for the installation of a flow meter on the 487 sewer extension in the amount of \$6836. Dan Fetterman seconded. Motion approved. Calvin Fox explained this must be done as the Township is bound by a contract with Orangeville Borough.

**New Business:**

Electric modifications: John Long made a motion to accept the bid from Mark Conner Electric in the amount of \$1975 to add the police department onto the generator and make modifications to the lighting in the back of the building. Dan Fetterman seconded. Motion approved.

Rate Increase 487 sewer extension: After discussion, John Long made a motion to approve a 22% rate increase on the 3 properties connected to the 487 sewer extension(resolution 02012024-1) and additionally split the bill of \$6836 for the flow meter in appropriate percentages and bill to the 3 residents with a 90 day grace period(resolution 02012024-2). Dan Fetterman seconded. Motion approved.
