## Call to Order:

The meeting of the Orange Township Supervisors was called to order at 6:30 pm by Supervisor Calvin Fox. Attending were, Supervisor Gene "Dan" Fetterman, John Thackray, Pat Brewster.

**Minutes:** Minutes from the June 1, 2023 meeting presented and approved.

**Recognition of Guests:** Pat asked if there were any regulations regarding fireworks use. She was advised she would have to talk with Chief Patel regarding this issue. The Township ordinances do not regulate fireworks.

11500 was deposited into a separate account for the police car fund. 10000 of this money was received from a Williams Company grant and 1500 was received from donations to the car fund. 13600 was deposited into the same account to be paid to Orangeville Borough as their 2<sup>nd</sup> payment for assets split at the dissolution of the Orangeville Police Board.

Personnel Policy addition regarding Cell phone use:

Section 8. CELL PHONE USE
